Terms and conditions of the Quotation Request and procedure for entering into an agreement with the *Bidder* are neither the terms of a public offer nor entail for the Customer any obligations pertaining to mandatory conclusion of a contract with the winner or other bidder.

**4. Subject of the Contract specifying quantity of goods to be delivered, scope of work to be performed and/or services to be provided:**

Repairs of CFM56-5B engines for Airbus A320 family aircraft. Information regarding quantity of the goods and scope of work and/or services is provided in the Terms of Reference (Section 4 of the Procurement Documentation).
