12. Refusal date from holding the request for quotations:

The Customer may without giving a reason take a decision to refuse from holding a request for quotations at any time without being liable to the bidders in request for quotations, including compensation for any expenses related to issuance and submission of the quote for participation in the request for quotations.

If it is taken a decision to refuse holding of the request for quotations the Customer shall bear no obligations or liability in the instance of a failure of the applicants, bidders in the request for quotations to familiarize themselves with a notice on refusal to hold such request for quotations.

The procedure for a request of quotations is neither bidding, nor auction for the right to be awarded a contract, or governed by Articles 447 - 449 Part One of the Civil Code of the Russian Federation. This procedure is also not a public bidding nor governed by Articles 1057-1061 of Part Two of the Civil Code of the Russian Federation. Thus, the terms of the Request procedure, procedure for entering into an agreement with the Bidder are neither the terms of a public offer nor entail for the Customer the relevant scope of obligations pertaining to mandatory conclusion of an agreement with the preferred bidder or other bidder.
